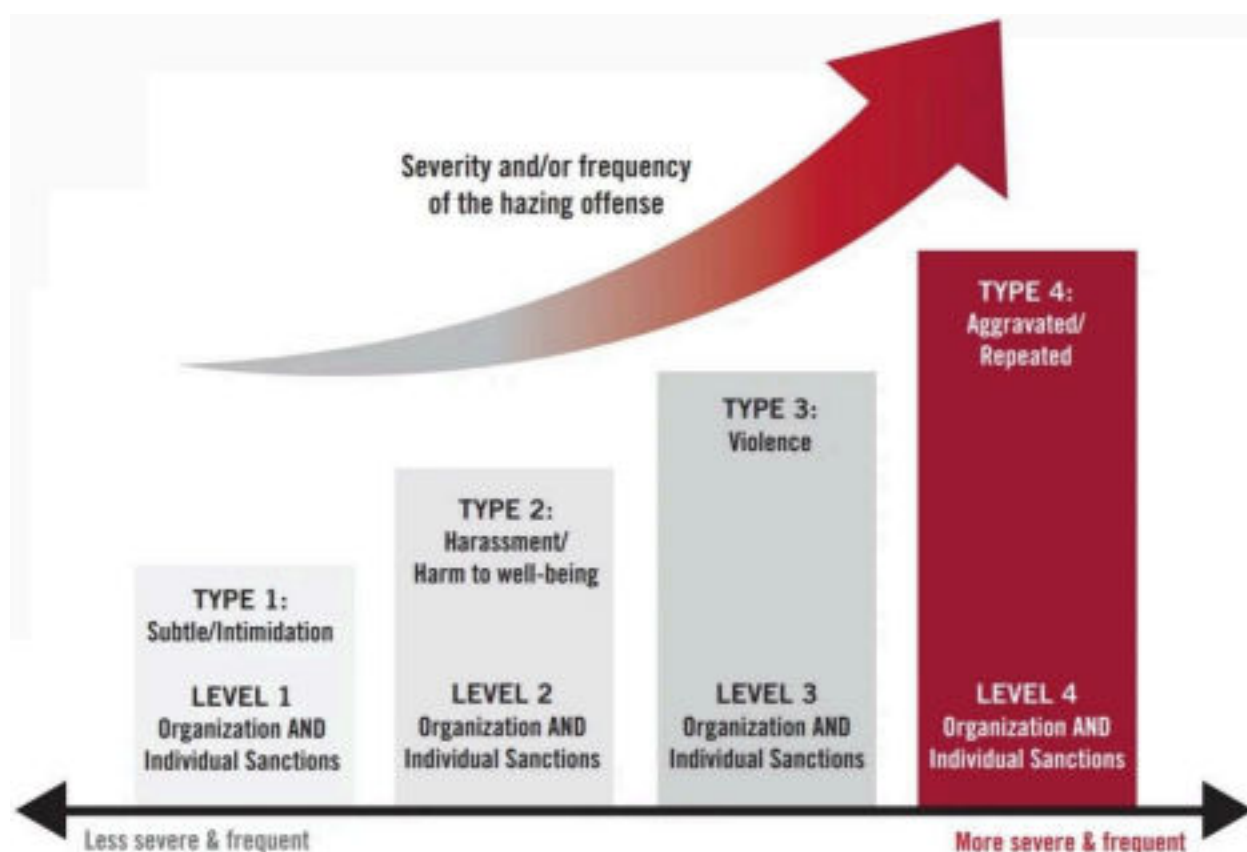

New members to the team including coaches were encouraged to participate in the "Senior Hit". This process required new members to line up on the football field in full football gear. They were informed they will receive a football "hit" by a senior who has chosen them. The senior would run at them and then just give them a hug or high five. The investigation concluded that no actual "hit" occurred, however this meets the criteria of intimidation.	The football coaches were instructed to stop all "senior hit" activities and anything associated with it. Coaches were to review any practices or traditions on the team that could be considered hazing. College athletic administrators reviewed the hazing policy and the stop campus hazing act with the football coaches to increase their understanding of what constitutes hazing.

New members were presented with a list of tasks to complete, called "Worm Rules". The new member had the choice to complete any, all, or none of the tasks on the list. This was presented to them by active members of the fraternity. The investigation found the tasks were presented as optional but new members were highly encouraged to and did complete some of these tasks.	A full review of all chapter bylaws and guidelines completed with chapter advisors. Gerlach Hall remained closed from the investigation date until the end of semester. 100% member completion of Hazing Education, Bystander Intervention and Living our Values workshops. Members create and present an anti-hazing lecture to IFC. Faculty and alumni advisors will annually review formal and informal initiation processes prior to recruitment.

Possible Sanctions & Outcomes

- Suspension of organizations for severe violations
- Probationary status with monitoring and required training
- Mandatory education programs on hazing prevention
- Loss of recognition for repeat or egregious offenses

Prevention & Education

- Hazing prevention workshops during student orientation
- Collaboration with national organizations such as StopHazing.org
- Annual awareness campaigns led by Student Life
